CANCELLATION POLICY - Stallholders who cancel their booking in the 14 days prior to the show day, or on the day will **not** be offered a refund under any circumstance. The same applies if you simply do not show up.

TERMS & CONDITIONS-

- **Wondai A.P & I Society Inc are not responsible for any claims against stallholders.**
- The operation of vehicles is to be at less than 10kms per hour (walking pace) with hazard lights on.
- Bump in is from 5am onwards and NOT before, with **no vehicle movement after 8am.**
- You will be sent your allocated site number/s 2 weeks prior to the event, once monies owing has been paid.
- This is a smoke free venue. Smokers please do so outside of the grounds.
- On arrival, **PLEASE** wait at the gate & you will be directed to your site.
- Please notify us if you require special circumstances i.e., Vehicle located with your stall - attached to a food trailer etc as you may be charged for extra meters.
- Stallholders must be ready to trade by 8am and must trade through till 5pm. Unless told otherwise by stall coordinator.
- Please leave your stall area clean and tidy.
- Stalls are not to exceed allocated area that have been booked & paid for and must stay in line with other stalls, no blocking the view to other stalls.
- Stallholders are reminded that they are required to take all trade waste with them on departure.
- It is the responsibility of all persons to comply with current Workplace Health & Safety Act.
- All electrical appliances and cords must be tested and tagged by a qualified electrical contractor in accordance with Queensland Electrical Safety Regulations 2002 and subsequent amendments.
- It is the Stallholders responsibility to ensure the products you sell conform to any safety and compliance standards pertaining to the product.
- In the interest of safety, marquees are required to have weights attached at all times. Market umbrellas need to have a weighted base with the umbrella stand able to be securely fixed to the weight. THIS is a condition of your trading.
